# **Zero tolerance of sexual abuse and sexual harassment; PREA coordinator**

**Auditor Overall Determination:** Meets Standard

#### **Auditor Discussion**

The Lake Region Residential Reentry Center (LRRRC) is operated by the Lake Region Law Enforcement Center. The LRRRC's PREA Policy follows the guidelines of the PREA standards. Throughout this report this will be referred to as the "PREA policy". The PREA policy mandates zero tolerance toward all forms of sexual abuse and sexual harassment and outlines the agency's approach to preventing, detecting, and responding to such conduct.

The center is operated by a county board of commissioners who have seats to provide representation of all the counties that make up this multi-county regional center. The day-to-day center administration is managed by the Operations Manager. The Operations Manager works very closely with the LRLEC Director and the PREA Coordinator who is tasked with maintaining PREA Compliance. The PREA Coordinator reports directly to the Captain and is a senior-level staff and directly oversees the center's PREA efforts in concert with the center's operations manager. The PREA Coordinator and the Operations Manager have the time and the authority

to carry out their PREA-related duties. It is important to note that during this last cycle this center experienced staffing shortages that required the PREA Coordinator work correctional officer shifts for a period of time. Although PREA-related activities did suffer during this period, they did continue, did not fall below compliance requirements, and as soon as normal staffing levels resumed, the PREA Coordinator assumed her normal duties and PREA related activities were resumed to the high level and expectations that she has set for herself. Throughout the audit process the staff were very responsive.

## 115.213 Supervision and monitoring

**Auditor Overall Determination:** Meets Standard

#### **Auditor Discussion**

The auditor interviewed the Chairman of the Lake Region Law Enforcement Center Governing Board, the Director, the Operations Manager, and the PREA Coordinator. The auditor reviewed the LRRRC PREA policy, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The LRRRC has one Operations Manager, one Case Manager and six (6) Reentry Officers. There is always one direct care staff on duty 24 hours each day. Typically, during the weekday there is one Operations Manager and one Case Manager on duty.

The auditor reviewed the last staffing plan that was completed in 2020. The Staffing Plan lists the staff and the resident numbers and physical layout. although staffing levels are reviewed on a continuous basis, a formal staffing plan has not been completed nor has the staffing plan been reviewed annually as required by the standard. The new Guardian rounds tracker system now records when the staff complete their housing rounds and alarms when they are close to missing the hourly round as required. There are multiple cameras throughout the facility that are monitored in the staff office. A new camera was added since the last audit to the kitchen storeroom. The facility is requesting an additional camera in the external yard as they have identified this area as a blind spot.

**CORRECTIVE ACTION:** The auditor required an annual staffing plan review. On September 20, 2023, the PREA Coordinator provided an updated staffing plan that

## 115.215 Limits to cross-gender viewing and searches **Auditor Overall Determination: Meets Standard Auditor Discussion** Reentry staff conduct rounds once each hour and all staff make the announcement when entering opposite gendered housing and prior to opening a resident's door. This was confirmed during the audit tour and through interviews with residents and with staff. LRRRC prohibits male staff from conducting cross gender searches of female residents. Female residents' access to regularly available programming is not restricted. All interviews with both residents and staff confirmed the practice. The policy prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures as confirmed through interviews. Staff are adequately trained in searches of inmates who are transgender or intersex, and such training is required by their policy. All staff did a great job with the back of the hand for opposite gender or transgendered searches. Residents shower in private shower stalls with shower curtains and toilet stalls with doors to provide privacy and to prevent observation by staff of the opposite gender or casual

## Residents with disabilities and residents who are limited English 115.216 proficient **Auditor Overall Determination: Meets Standard Auditor Discussion** The LRRRC will provide PREA information to all residents with disabilities including residents who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities so that they have an equal opportunity to participate in or benefit from all aspects of LRRRC's efforts to prevent, detect, and respond to sexual have access to use the interpretive service for all communications other than day-to[1]day routine communication. There were no non-English speaking residents at the facility during the audit. The LRRRC will provide basic PREA information verbally to residents who are blind or visually impaired, those who have intellectual, psychiatric, or disabilities. They provide written information to residents who are deaf or hard of hearing or if required, they will provide an ASL interpreter. The LRRRC uses the Language Link for translation services.

## 115.217 Hiring and promotion decisions **Auditor Overall Determination: Meets Standard Auditor Discussion** The LRRRC Policy 305 Recruitment and Selection governs the hiring process and includes the components required by this PREA standard. Law enforcement background checks are run upon hire. They are also re-ran every five years. The LRRRC ran background checks on all staff in 2020 and every new hire since that time. They will run all staff again in 2025 and continue this process every five years to ensure that background checks are always current. The LRRRC asks the required questions within their hiring process regarding any previous sexual misconduct and documents this on a form that is signed and dated by each employee. This form also requires that the employee acknowledges understanding of the required continuing duty to report any adverse contact with law enforcement or sexual misconduct throughout the terms of their employment. These questions are asked again annually of each employee. The facility checks with all previous institutional employers specifically regarding substantiated allegations of sexual abuse and provided documented evidence to support this. The auditor verified these requirements were met by interviewing staff and viewing a sample of the required documentation.

115.218	Upgrades to facilities and technology

	The auditor reviewed the LRRRC PREA policy, video monitoring systems, directly observed the facility and conducted interviews with the Chairman of the Lake Region Law Enforcement Center Governing Board, the Director, the Operations Manager, and the PREA Coordinator. The facility considers protection of residents and the standards when contemplating upgrades to the facility or in the application of technology. Recently the agency added a Guardian rounds tracker system to ensure hourly rounds are conducted and documented as required. Also, the facility has enlarged their staff office where camera monitoring equipment is located to better aid in resident observation and better flow of resident traffic. They have camera systems in key areas. The camera systems are upgraded as needed throughout service.

115.221	Evidence protocol and forensic medical examinations

#### **Auditor Discussion**

The auditor reviewed the PREA policy and interviewed both the criminal and administrative investigators that conduct investigations. The auditor spoke with the director at Safe Alternatives for Abused Families (SAAF) who provides an advocate for accompaniment, victim support services, a sexual assault examination room and a Sexual Assault Nurse Examiner (SANE). Residents who have been sexually assaulted can be transported to SAAF where the SANE will conduct a forensic medical sexual assault examination. The LRRRC has a Memorandum of Understanding (MOU) with SAAF for these services. When law enforcement responds to a sexual assault case within the center, evidence protocol is followed, and they work cooperatively with the SANE to ensure all usable physical evidence is gathered. The LRRRC has an MOU with the Devils Lake Police Department to provide investigations in accordance with PREA standards 115.221.

# 115.222 Policies to ensure referrals of allegations for investigations Auditor Overall Determination: Meets Standard **Auditor Discussion** The PREA policy requires the facility refer all allegations for investigation. The LRRRC investigations are completed by qualified investigators and required documentation and reporting occurs. There are trained administrative investigators from the facility and criminal investigators from the Devil's Lake Police Department available to investigate allegations of sexual misconduct within the center. The administrative investigators have completed the North Dakota Department of Corrections and Rehabilitation's (NDDOCR) course PREA Investigator Training. Staff sexual misconduct may be investigated through an independent investigation conducted by the North Dakota Bureau of Criminal Investigations if referred by the police department. The investigative policy is published on correctional facility's website but is not on the LRRRC's webpage. **CORRECTIVE ACTION:** The auditor required that the investigative policy be published at https://www.lrlec.org/LRRRCreports.html. On June 20, 2023 the auditor

and reviewed training documentation. Newly hired staff have orientation training which includes the required components of this PREA training standard. Staff sign an acknowledgement form that they understand the requirements of PREA, the facility's zero tolerance policy and that they must immediately report any information or knowledge of sexual abuse or sexual harassment. However, they were using their acknowledgement form that they also use for volunteers and contractors. The training documentation forms should be relevant to the material that they cover. New hires participate in training through the National Institute of Corrections (NIC) video PREA: Your Role Responding to Sexual Abuse, a review of the agency PREA policies, and some basic in-person training provided to them by the PREA Coordinator. For refresher training by existing employees they provide inservice training and policy review through various methods such as NIC, Corrections One, Lexipol, LocalGov, the Justice Clearinghouse, and presentations taught by the PREA Coordinator. Staff were knowledgeable in the required competencies such as the correct first responder response - separate, provide care, protect evidence, call for assistance, notify the supervisor and provide a written report. However, the training documentation pulled in the random sample was very spotty and what is documented, is recorded in numerous different ways.

**CORRECTIVE ACTION:** The auditor required more consistent and formalized methods of documenting the training. The training for staff should state which curriculum they used in completing the training. The PREA Coordinator provided new-hire and employee PREA training completed during the corrective action period with consistent documentation.

115.232	Volunteer and contractor training

	The LRRRC does not utilize internal volunteers and contractors. All services are provided to the residents outside of the facility within the community. If the agency were to utilize volunteers or contractors in the future, they would ensure they have the required training.

	The LRRRC provides basic information to a resident during the intake process about the center's zero tolerance policy and how to report. The information is presented to

the resident during the intake process by going over key components of the handbook information and then requiring the resident to sign. The resident also views the video "What You Need to Know" and signs an acknowledgment form. The handbook lists both the Devils Lake Police Department and Safe Alternatives for Abused Families (SAAF) as reporting options. The form they sign only lists SAAF as a reporting option. These items need to be corrected to remove SAAF as a reporting option and only list SAAF under victim support services. Center staff review this information orally with residents with low literacy or comprehension levels or other disabilities or issues that may prevent them from learning this information on their own. PREA information is readily available throughout the resident's stay on posters and in their handbook. The auditor verified compliance with this standard through staff and resident interviews and by reviewing a sample of training for residents.

**CORRECTIVE ACTION**: The auditor required the reporting information be corrected in the handbook and PREA Training Acknowledgement form to list only the Devils Lake Police Department as a reporting option and SAAF contact information under the heading "Victim Support Services". On June 28, 2023, the PREA Coordinator provided the updated poster, handbook and PREA Training Acknowledgement form.

## 115.234 Specialized training: Investigations

Auditor Overall Determination: Meets Standard

#### **Auditor Discussion**

The LRRRC has trained facility investigators to conduct administrative investigations. The administrative investigator has completed the North Dakota Department of Corrections and Rehabilitation's (NDDOCR) course PREA Investigator Training. All criminal allegations are turned over to the Devils Lake Police Department for investigation. The investigator through the police department has extensive law enforcement experience and has completed various training specific to sexual assault investigations. He continuously refreshes his training by attending training on sexual abuse investigations such as the one he is enrolled in for next month. He works with others to form a coordinated response effort to include the SANE nurse and the advocates from Safe Alternatives for Abused Families (SAAF). Specialized training included techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. The department may refer allegations of staff criminal sexual misconduct to the North Dakota Bureau of Investigations.

# 115.235 Specialized training: Medical and mental health care Auditor Overall Determination: Meets Standard

#### **Auditor Discussion**

The auditor interviewed the nurse. The nurse was recently hired on a part-time basis but will be going full time at the end of June. The nurse was made aware by the PREA Coordinator that she needs to complete specialized training through the National Institute of Corrections "PREA 201 For Medical and Mental Health Practitioners" by the end of the month. The previous nurse had the required specialized training.

They do not conduct forensic exams at this facility. As indicated through the interviews, she is knowledgeable in how to detect and assess signs of sexual abuse and sexual harassment; how to preserve physical evidence of sexual abuse; how to respond effectively and professionally to victims of sexual abuse and sexual harassment; and how and to whom to report allegations or suspicions of sexual abuse and sexual harassment. All residents who would report a sexual assault and need a forensic medical examination are transported to the local rape crisis center, SAAF, who has SANE services. Medical staff verbally inform residents that they must report any incidents of sexual abuse or sexual harassment that occurred within a facility. They would obtain informed consent prior to reporting incident about prior sexual victimization that did not occur in an institutional setting.

**CORRECTIVE ACTION:** The auditor required that the nurse complete the NIC specialized training for health care providers and provide the documentation to the auditor. On June 27, 2023, the PREA Coordinator provided the requested training documentation.

## 115.241 Screening for risk of victimization and abusiveness

Auditor Overall Determination: Meets Standard

#### **Auditor Discussion**

The auditor spoke with the Operations Manager, the PREA Coordinator, staff and residents, reviewed PREA policy, and reviewed resident screening documents. The LRRRC completes a screening process upon intake. The screening has all the required components as stated in the standards. Staff confirmed that they are continually reassessing a resident's status. The auditor reviewed a sample of resident reassessments that were conducted within 30 days of the initial intake. Residents who are transgender or intersex are reassessed at least twice each year. Residents are also reassessed if referred, requested by a staff member, there is an incident of sexual abuse or there is receipt of any other information that increases the resident's risk of sexual victimization or abusiveness.

## 115.242 Use of screening information

#### **Auditor Overall Determination:** Meets Standard

#### **Auditor Discussion**

The LRRRC screening process is used along with other classification methods to determine placement within their housing areas. There are enough housing options to keep residents separate if the screening indicated this was necessary. All residents shower separately from other offenders. The center considers the concerns of a transgendered or intersex resident's own view with respect to his or her own safety. Those views are given serious consideration, and this was demonstrated through the interviews of staff and residents. The facility does not place lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive.

## 115.251 Resident reporting

**Auditor Overall Determination: Meets Standard** 

#### **Auditor Discussion**

The auditor interviewed administrators, staff, and residents, reviewed the policy and the resident handbook, and toured the facility. The LRRRC provides multiple external ways for residents to report sexual abuse and sexual harassment. Residents can call externally to family and friends, and call or write to the Devils Lake Police Department.

The facility has residual information left in their handbook and on the documentation of resident PREA education about report to SAAF, the rape crisis center in Devils Lake.

The LRRRC provides multiple internal ways for residents to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. They can report verbally to staff, write a grievance, put in a sick call slip and report to medical staff or the case manager. They also can speak with the Director, the Operations Manager, or the PREA Coordinator by making a request at any time. Staff accept reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. Staff can privately report to any staff within their chain of command or outside of the chain of command to any administrator.

**CORRECTIVE ACTION:** The auditor required that all references in the handbook, on training materials and on posters to SAAF as a reporting entity should be removed. SAAF should only be listed on materials as a victim support service. On June 28, 2023, the PREA Coordinator provided the updated handbook, training materials, and

posters that do not list SAAF as a reporting entity.

115.252	Exhaustion of administrative remedies

	The LRRRC PREA policy states that sexual abuse and sexual harassment allegations are exempt from the grievance process and can be reported at any time. The resident handbook does not address the informal grievance process relative to sexual abuse or sexual harassment.

On June 28, 2023, the PREA Coordinator provided an updated handbook that stated the grievance process should not be used for this purpose.

115.254	Third party reporting

	The LRRRC website does not provide information on how an individual can make a third-party report. This information is on another Lake Region Law Enforcement Center webpage under the correctional facility. Third parties can report sexual abuse and sexual harassment to the Director, the Operations Manager, or the PREA Coordinator, and the phone number and address is provided on the correctional

center website. Interviews with staff and residents confirm that staff and residents are aware that third-party reporting options are available. The LRRRC provides residents with reasonable and confidential access to their attorney. In addition, residents interviewed reported that they had contact with their families and others regularly who could report on their behalf.

**CORRECTIVE ACTION:** The auditor requires that the third-party reporting information be repeated on the LRRRC's webpage at https://www.lrlec.org/LRRRCreports.html. On July 20, 2023, the auditor verified that the LRRRC's webpage had third-party reporting information.

# Auditor Overall Determination: Meets Standard Auditor Discussion The facility PREA policy requires all staff to immediately report any knowledge, suspicion or information received related to sexual abuse/harassment incidents, retaliation and staff negligence that may have contributed to such incidents. Staff are required to make such reports to the Operations Manager who immediately notifies the LRLEC administrators and the PREA Coordinator. All employees may privately report sexual abuse and sexual harassment of residents to their supervisor or any other facility supervisor. Random staff interviews confirmed their responsibility to report and to maintain that information in confidence. The PREA Coordinator, the Director, or designee, will assign an investigator for all allegations of sexual abuse and sexual harassment, including third-party and anonymous reports. Staff interviews confirmed their responsibility to report and to maintain

that information in confidence.

## Auditor Overall Determination: Meets Standard Auditor Discussion The auditor reviewed the PREA policy, interviewed the staff and the administration. The facility requires all staff to take immediate action to protect the resident from imminent sexual abuse. All staff understand that "immediate" means when the response is needed - that could mean within minutes if the abuse were recent, or it could mean before the end of the shift for incidents in which an abuse was reported that occurred in the distant past. There have been no reported incidents over the past 12 months in which immediate protection measures were required because a resident was subject to a substantial risk of imminent sexual abuse.

Such action is initiated no later than 72 hours and actions are documented. These steps were also noted in the review of the policy. These notifications are made from facility head to facility head. There are no instances of such allegations received regarding another facility or from another facility regarding an incident at this facility for the past 12 months.

SAAF typically handles the response at their facility which includes a SANE, an advocate for emotional support services and

Measures include housing changes, removing contact of alleged staff/resident abusers and emotional support services for those who fear retaliation. In the event of an incident, the PREA Coordinator's monitoring efforts includes periodic status checks with the victim and/or anyone who suspects retaliation for reporting or cooperating with an investigation.

	The auditor interviewed upper-level staff and the investigators. There were no investigative files for the reentry center to review. However, the auditor reviewed files for the correctional facility that are also completed by the PREA Coordinator. Through the interview with both an administrative and the criminal investigator it

was determined that investigations are not terminated should the source of the allegation recant. Should criminal prosecution be considered, the investigator coordinates with the state's attorney. Polygraph tests are not used during their investigations. The credibility of those interviewed by investigators is believed to be true until corroborating facts tell otherwise and is not made on the basis of that individual's status as a resident or staff. All written reports are retained for as long as the alleged abuser is incarcerated or employed by the facility plus five years. Investigations will not be terminated due to the departure of an alleged abuser or victim. These steps are properly documented in the PREA policy. The investigators have completed specialized training. The investigations include efforts to determine whether staff actions/failures contributed to the abuse documented through written reports, which will include physical/testimonial evidence, credibility assessments and investigative facts and findings.

	The investigator was knowledgeable as to the standard for administrative investigations. They are fully aware that the facility uses no standard higher than the preponderance of evidence in making final determinations of sexual abuse/ harassment - meaning that the facility can take necessary actions when at the conclusion of the investigation the evidence leads them to believe the incident more than likely occurred (greater than 50%).

The auditor interviewed staff, and the investigators. The PREA Coordinator uses a form to report the outcome to the resident. If the allegation is against a staff member, the form includes information about if the staff is no longer posted in the resident's unit and/or if the staff is no longer employed at the facility. The form also includes information regarding if the alleged abuser is indicted on a charge related to sexual abuse within the facility or has been convicted of an offense related to the sexual abuse within the facility. The resident signs the form to document receipt of this information. The outcome states whether the allegation has been determined to be substantiated, unsubstantiated, or unfounded. If the resident refuses to sign the findings form or the resident is no longer in custody at the facility, the PREA Coordinator will document this on the form. There were no incidents reported at the reentry center.

Disciplinary sanctions for violations of agency policies relating to sexual abuse or sexual harassment (other than actually engaging in sexual abuse) are commensurate with the nature and circumstances of the acts committed, the staff member's disciplinary history, and the sanctions imposed for comparable offenses by other staff with similar histories. All terminations for violations of agency sexual abuse or sexual harassment policies, or resignations by staff who would have been terminated if not for their resignation, are reported to law enforcement, unless the activity was clearly not criminal.

According to the Director, should any violation of this type be substantiated, the facility has complete authority to administer remedial measures including prohibiting further contact with residents. Contractors or volunteers who engage in sexual abuse will be reported to law enforcement agencies (unless the activity was clearly not criminal). These requirements are outlined in their policy.

The LRRRC does not provide counseling or therapy to address and correct the underlying reasons or		

motivations for abuse. If findings of resident-on-resident sexual abuse are substantiated, administrative sanctions will be administered following the formal disciplinary processes and applied commensurate with the level of infractions. Some examples given by the Director are loss of privileges and other minor sanctions for minor infractions. More serious infractions would be room restrictions, transfer, and additional criminal charges.

	Emergency medical response was not needed during the review period. The PREA policy documents PREA requirements for access to emergency medical and mental health services. Emergency services would be provided by Mercy Hospital. The LRRRC would coordinate with the Lake Region Human Services Center or the referring agency (BOP, NDDOCR) to provide mental health services. Treatment services are provided to the victim without financial cost regardless of whether the victim names the abuser or cooperates with the investigation. The procedures were verified both through review of policy and through conversations with staff, the nurse, and the case manager.

# Ongoing medical and mental health care for sexual abuse victims and abusers Auditor Overall Determination: Meets Standard Auditor Discussion The auditor interviewed upper-level staff, and the nurse, and reviewed the PREA policy. The LRRRC will offer a medical evaluation and, as appropriate, offers treatment to all offenders who have been victimized by sexual abuse in any prison, center, lockup, or juvenile facility. The evaluation and treatment will include follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from custody. The LRRRC provides such victims with medical and mental health services consistent with the community level of care. Offender victims of sexual abuse are offered tests for sexually transmitted infections and pregnancy as medically appropriate.

The auditor interviewed the Director, the Operations Manager, and the PREA Coordinator. The auditor recommends that rather than a free-flow narrative report they use some type of incident review form so that all questions are asked during the review process – change in policy or practice, motivation, physical barriers, staffing levels and monitoring technology. The review team includes the Director, the Operations Manager, the PREA Coordinator, the investigator, upper-level administrative staff, the case manager, and medical staff when appropriate.
